## CPP31418 Certificate III in Close Protection Operations (QLD Class 1 Licence)

#### **Overview:**

This course is for those wishing to apply for a Queensland Bodyguard Licence. A bodyguard's job is to protect the personal safety of a specific individual. This qualification specifies the outcomes required to ensure the safety of persons at risk under various security assignment conditions. It requires the ability to plan and prepare security arrangements, implement security and safety policies during escort activities, and monitor and review the effectiveness of the security assignment.

#### **Pre-requisites:**

As an assessment requirement of the HLTAID014 unit, participants must be able to perform at least 2 minutes (5 cycles) of CPR on an adult resuscitation manikin that is placed on the floor. Participants must have sufficient skills to read, write and communicate in English, and have access to a computer with internet access and Microsoft Word. Mobile phones and tablets cannot be used to complete the online training component of this course. Participants must also be physically fit, and able to perform defensive tactic techniques.

#### Licence & Regulatory Requirements:

HLTWHS003 – Maintain work health and safety

All Queensland Security Licences are administered by <u>Office of Fair Trading</u>. All participants are encouraged to read through the requirements of a <u>Queensland Security License application</u>, as there is additional requirements & fees payable to Office of Fair Trading. For example, participants must be over the age of 18, must be a fit and proper person, cannot have had any <u>disqualifying offences</u> under the criminal code in the last 10 years.

#### **Delivery method:**

This course is run as a blend of online/self-paced learning and face-to-face training. Online training + 3 days classroom.

The online training is approximately 15-20 hours per unit (for a total of 14 units), however this greatly depends on the individual and their experience. Online/self-paced training – this involves reading a student manual and completing written, case scenario and online practical assessments (using Microsoft Word). Online training must be completed prior to booking in for the face-to-face training. Students have 12 months to complete this course from the date of enrolment.

Support for this online training is done via email with an assessor.
